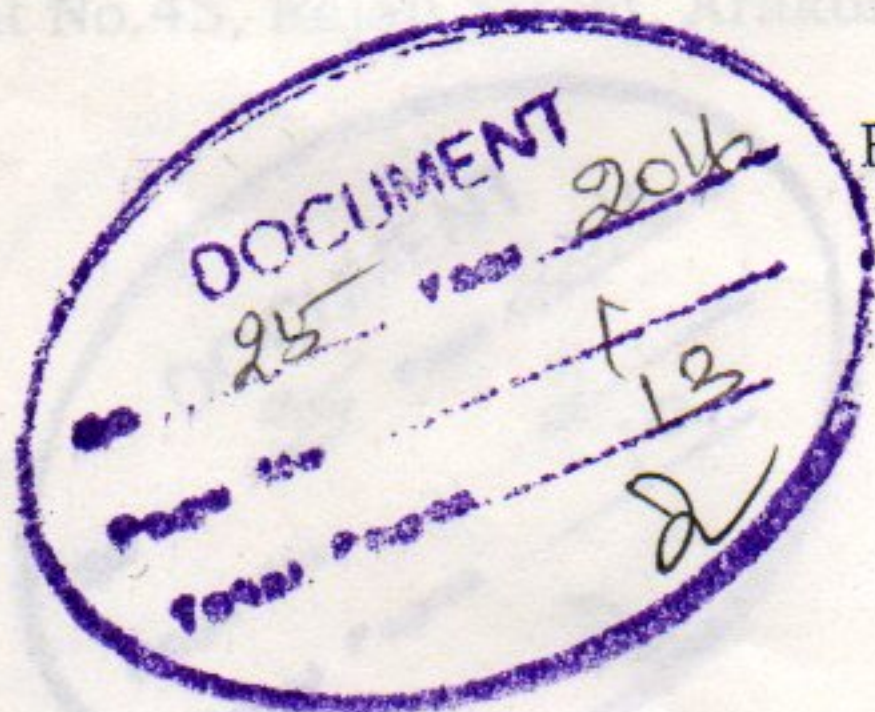

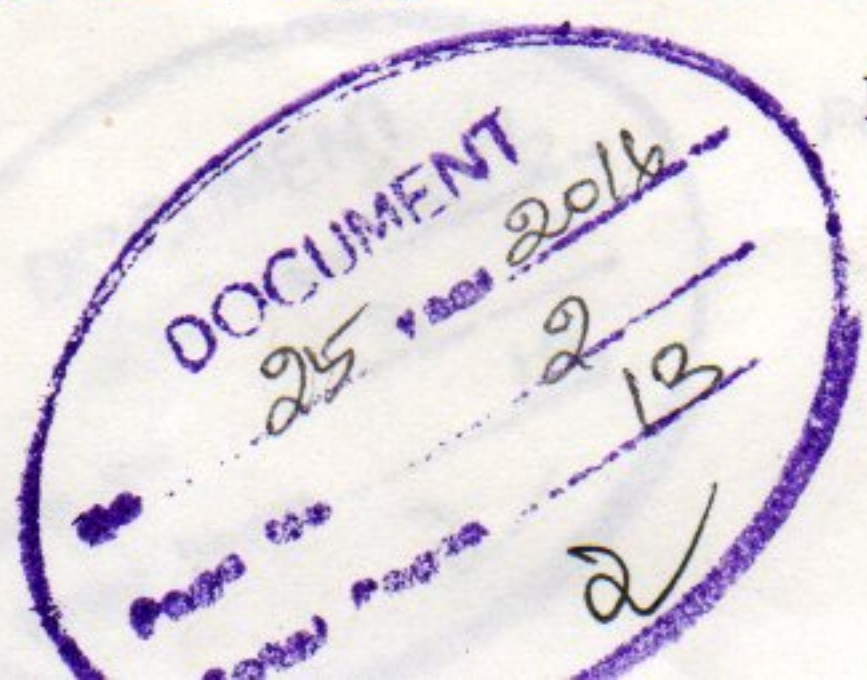
NOW THIS DEED OF TRUST WITNESSETH AND DECLARES AS FOLLOWS:

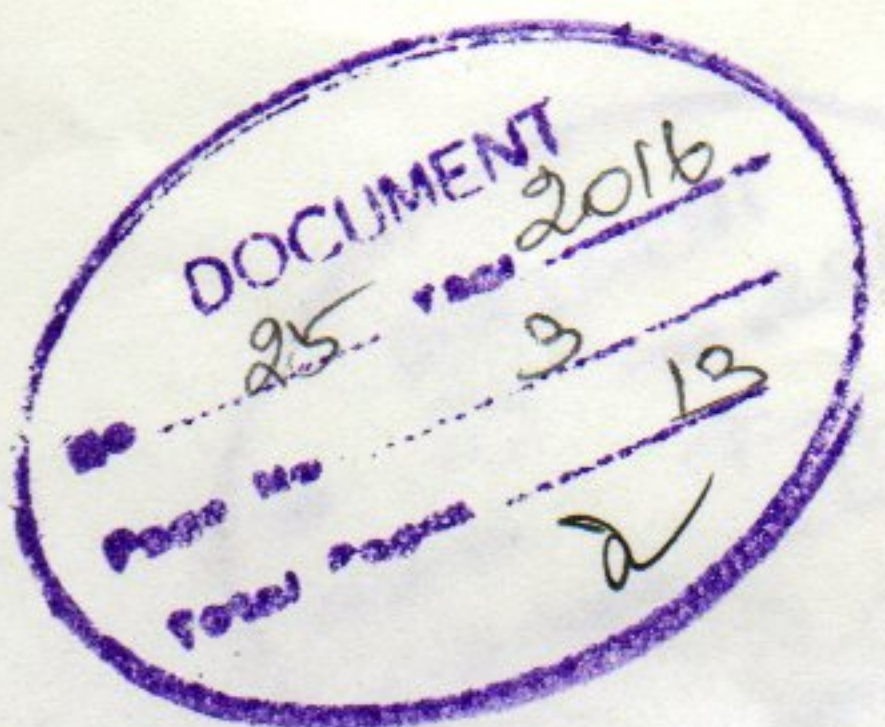

2. PLACE: Tamil Nadu or such other place or places as the Trustees may decide from time to time.
3. OBJECTS: The objects of the Trust are:
  - a. To run educational institutions and other related activities.
  - b. To establish and /or contribute to, support, or maintain by monetary gifts or otherwise, educational institutions, colleges, schools, libraries, book-trusts, reading room, industrial training institutes, technical institutes, teachers training institute, polytechnics, workshops, research institutes and other public educational or charitable institutions or societies.
  - c. To hold and promote education and learning including primary, higher and college education, technical, non-technical, agricultural, engineering, medical, pharma, nursing, commercial, financial, management, scientific philosophic or any subject relating to arts, culture or any other subject of education and research work in all subjects, and to establish, run, maintain or finance by adhoc or annual grants or otherwise schools, colleges and/or other institutions for all or any of the aforesaid purposes.

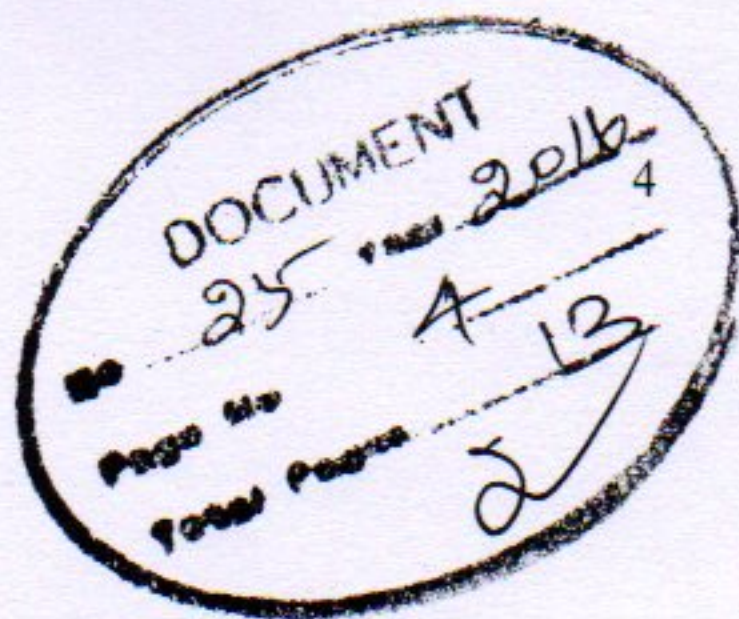


- d. To establish professorship, lectureships and to give scholarship and prizes or any other similar help or encouragement for the advancement of education.
- e. To make pecuniary grants by giving scholarships, education fees, fellowships, stipends or otherwise to deserving or meritorious or poor students for their studies, research and training, education, etc. in any branch including free supply of their food, clothing, residence, books, etc.
- f. To establish, construct, maintain, finance by adhoc assistance or otherwise, hospitals, nursing homes, medical colleges, wards and institutions for the relief of the sick and to aid and co-operate with other institutions and societies doing similar work.
- g. To conduct lectures, seminars, symposiums and conferences on all subjects and to award scholarships, prizes or trophies for the advancement of the above objects.
- h. To contribute or donate to any benevolent or charitable purposes and to establish Funds therefore.
- i. To do all such things as may be necessary or conducive for the advancement of the objects above mentioned.
4. TRUST FUND: The Author of the Trust declares that the sum of Rs.1,001 (Rupees One Thousand and One Only) that has been dedicated by him for public charitable purposes and objects of running educational institutions as described above, the receipt of which the TRUSTEES have acknowledged and that the TRUSTEES shall and will stand possessed of the said sum of Rs.1,001(Rupees One Thousand and One Only) upon Trust and also any other properties, movable or immovable, which the Trustees may from time to time receive for augmenting the Trust Fund or for specified purposes connected with the objects of the Trust not calculated to impede the due working of the Trust arising from donations, bequests, gifts, legacies or grants in cash or kind or from any other sources whatsoever and also of any investment for the time being representing the same ( hereinafter called the Trust Fund) and also of the net income from the Trust Fund into Trust, and to apply both the income and the capital of the Trust Fund for the purposes of the Trust.

The Trust Fund shall be held in the name of the Trust and not in the name or names of the Trustees.

If the objects for which this Trust has been created shall fail, or cannot be satisfactorily fulfilled for any reason, the Board of Trustees shall be at liberty to apply the Trust Fund or any portion, thereof to any other Trust or Institution having objects wholly or in part similar to this Trust.

5. THE TRUSTEES: The first board of Trustees shall consist of the following persons

- i. Sri. E.Praveen Kumar S/o Sri.Ethirajulu, aged about 31 years, residing at No.45, 1<sup>st</sup> Rajaji Street, Arakonam, , Vellore District - 631 001.,
- ii. Smt.Vidya Ramamoorthy W/o Sri. E.Praveen Kumar, aged about 22 years, residing at No.13/3B, Subbarayar Street, Kanchipuram - 631 502.
- iii. Sri.M.Karthikeyan S/o Mr.Munusamy, aged about 31 years, residing at No.141, Bajanaikoil Street, Kizhavanam, Arakonam, Vellore District - 631 101.

The following shall be the first team of office bearers, from among the trustees of the trust:

1. Sri.E.Praveen Kumar - Chairman/Managing Trustee
2. Sri. Karthikeyan.M - Secretary
3. Smt.Vidyaramamoorthy - Treasurer

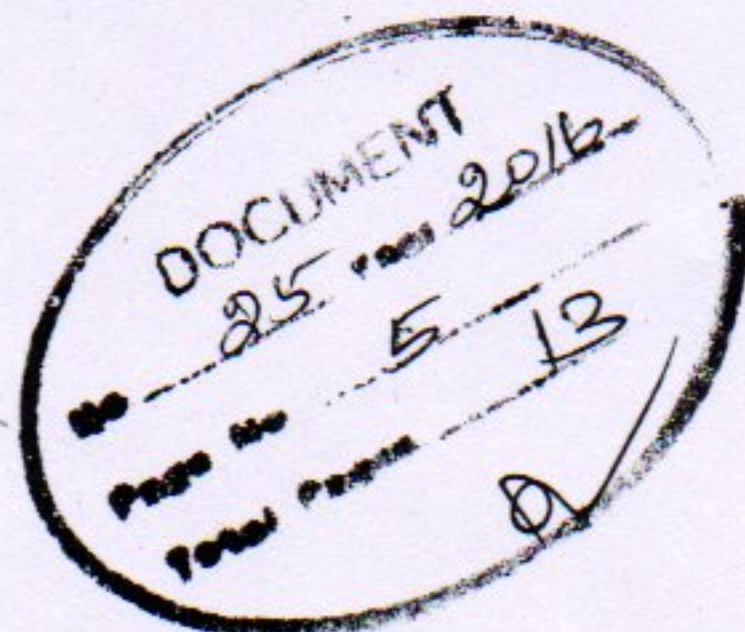
In the event of non-life Trustees being office bearers, they shall hold the office for a period of three years in rotation and shall get themselves re-elected at the end of the three year period.

- a) The number of Trustees shall not be less than two and shall not exceed ten.
- b) The number of Trustees may be altered accordingly to the decision of the Board of Trustees.
- c) Vacancies caused by removal, death, retirement, resignation or by any other incapacity or reason in the board of Trustees shall be filled by co-option by remaining Trustees.
- d) The chairman of the Trust shall manage the affairs of the Trust on behalf of the Board of Trustees and shall be the person to sue or be sued on behalf of the Trust.

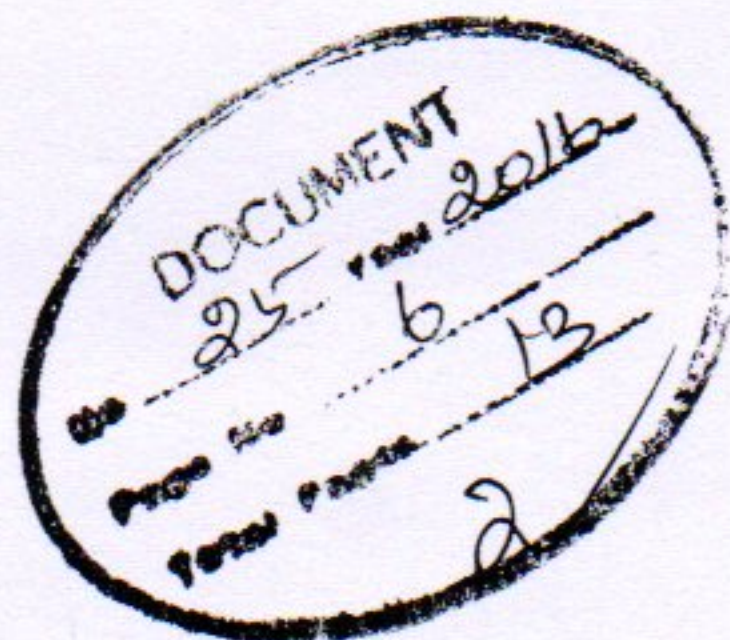


6. POWERS OF TRUSTEES: Without prejudice to the General Powers of the Trustees to manage the Trust, the Trustees shall have the following powers for the management and administration of the Trust and for the execution of the objects of the Trust.
- a. To keep the Trust properties or apply the Trust Funds for the acquisition of any kind of property or assets whatsoever including movable, immovable, actionable claims, securities, or any other form of property.
  - b. To open one or more bank accounts in the name of the Trust anywhere in India and the chairman shall be authorized to have the power to operate such bank accounts individually until decided otherwise by the board of trustees.
  - c. To invest Funds of the Trust in any movable or immovable property in any part of the country (India) and further will have the power to sell or vary such investments according to their discretion from time to time with prior permission of the Director of Income Tax (Exemptions).
  - d. The chairman of the Trust shall maintain or cause to be maintained proper books of accounts of the monies, properties, income and expenditure of the Trust which shall be audited every year by a Chartered Accountant duly appointed for the purpose.
  - e. The Trustees shall have power to collect rent, interest or other income and invest the Trust Fund and vary such investments from time to time and sell or realise the investment for the purpose of the Trust. However, the Trustees shall have the powers to mortgage, raise loans or encumber, sell or lease or otherwise alienate the immovable properties, if any of the Trust unless and until necessity or occasion compels such a sale, transfer or encumbrance, or other alienation of the immovable properties, in any such event, any two Trustees shall be competent to sell, lease, encumber or otherwise alienate the properties of the Trust, after due authorisation from the Board of Trustees with prior permission of the Director of Income Tax (Exemptions).
  - f. To do all such acts and things as are necessary for the control and management of the affairs of the Trust and for purposes of attainment of the objects of the Trust.
  - g. To raise such loan or loans from banks/financial institutions/others for the benefit of the Trust and to offer as security the movable and immovable properties of the Trust and to sign such promissory notes, bills of exchange, hundies or any other financial documents that may be necessary for and on behalf of the Trust.

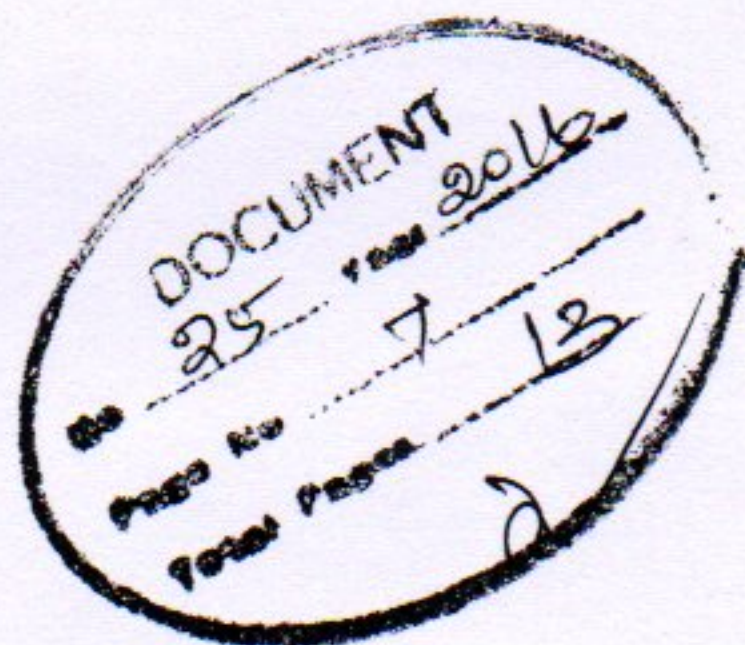


- h. To settle, compromise or compound all or any of the debts, claims, outstanding amounts, disputes, demands, actions, suits and proceedings, whatsoever by or against in any other manner related to the Trust or refer the same to Arbitration.
  - i. To lend or invest the surplus Funds of the Trust in such manner as may be decided by the Board of Trustees.
  - j. To incur all such expenses as are necessary for the execution of the Trust and powers under these presents.
  - k. To appoint Auditors to audit the accounts of the Trust.
  - l. To appoint legal advisors for the Trust.
  - m. To appoint such staff as may be necessary for the due administration of the Trust on such remuneration, commission or salary as the Trustees may think proper and suspend, remove or replace them whenever necessary.
  - n. To reimburse the Trustees towards the out of pocket expenses which may be incurred by them in the course of or in relation to the affairs of the Trust.
  - o. To receive in cash or kind donations, contributions, gifts, bequests, legacies and endowments from individuals, charitable or other Trust or institutions for the objects of the Trust on such terms and conditions as may be accepted by the Trustees.
  - p. To make, alter, rescind any rules or regulations in regard to the conduct of affairs in respect of which any power or duty is vested in them for the convenient and effective management and administration of the Trust.
7. POWER TO CO-OPT: The Trustees shall have the power to co-opt additional Trustees or to fill up any existing vacancy in the Board of Trustees, so however, that the total number of Trustees shall not be below or exceed the number fixed in clause 5(a) supra.
8. VACANCIES OCCURRING IN THE OFFICE OF THE TRUSTEES: The vacancies occurring in the office of the Trustees shall be filled by the remaining Trustees within 3 months of the arising of such vacancies. If there are no Trustees, functioning at any point of time, the Trustees shall be appointed in accordance with the law by a court of competent jurisdiction. Where at any time the number of Trustees fall below the minimum prescribed in clause 5(a) supra, the continuing Trustees shall give the power to co-opt any person or persons to fill up such vacancy.

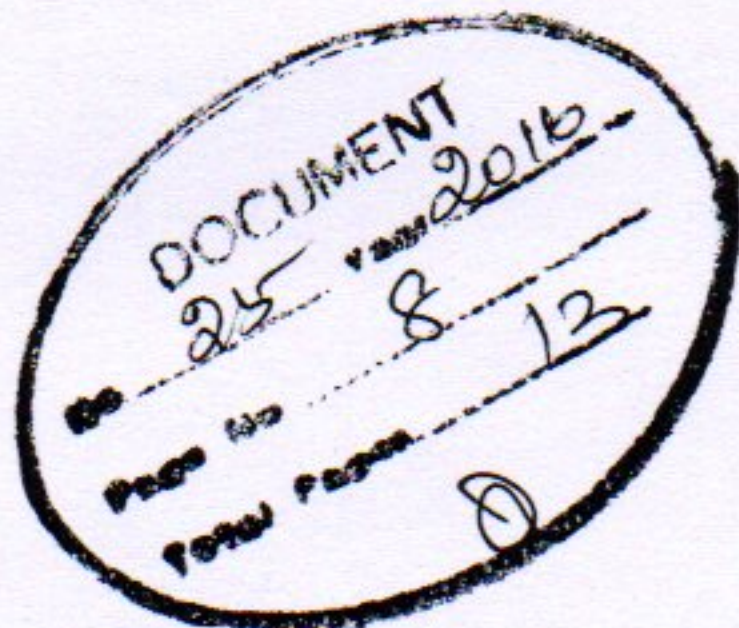


9. VACANCY NOT TO INVALIDATE THE PROCEEDINGS: Any vacancy in the Board of Trustees and /or any illegality in appointment of Trustees, their proceedings shall not invalidate any prior act or decision of the Board of Trustees.
10. ADMINISTRATION: The Board of Trustees shall have full power and authority to administer the Trust, its properties and affairs and do all acts, deeds and things which are calculated to fulfill the performance for which the Trust is established. The Board of Trustees shall act through the Chairman of the Trust.
11. PROCEEDINGS OF THE TRUSTEES: The Board of Trustees may meet as often as may be necessary for the efficient conduct of the Trust. The Trustees may take decisions on any matter either at their meetings or by circulation of resolution on papers. If any of the Trustees are absent for 3 consecutive Board Meetings without a prior leave of absence sanctioned by the board, he shall be deemed to have vacated his office
12. QUORUM: The minimum number of Trustees to be present for conducting a meeting of the Board of Trustees shall be 2 or 1/2th of the Total number of Trustees whichever is less.
13. VOTING: Each Trustee shall have one vote. The Chairman of the Trust shall have the casting vote. The opinion of the majority of the Board of Trustees present at a meeting shall be final in respect of all matters relating to the Trust. In case of the voting pattern being even the Chairman of the Trust shall exercise the casting vote and such decision shall be final.
14. MINUTES, ACCOUNTS AND AUDIT: The Trustees shall maintain true and correct accounts of the Trust and a correct record of their deliberations and get the accounts duly audited by a Chartered Accountant.
15. NET INCOME OF THE TRUST: The Trustees shall invest and recover the income of the Trust Fund and shall provide for all costs, charges, incidental expenses, including insurance premium expenses of ordinary repairs etc. and all other out goings and expenses for the management and administration of the Trust.
16. CREATION OF RESERVES: The Trustees shall set apart and credit to the depreciation sinking or other Fund, such percentage of, or portion or whole of the income of the Trust Fund as may from time to time be determined by the Trustees. However, as and when the balances standing to the credit of such Fund exceeds the minimum amount, which the Trustees may from time to time consider sufficient. It shall be lawful for the Trustees to transfer such surplus amount to the General Trust Fund and apply it in the same manner as the Net income or the Trust Fund.

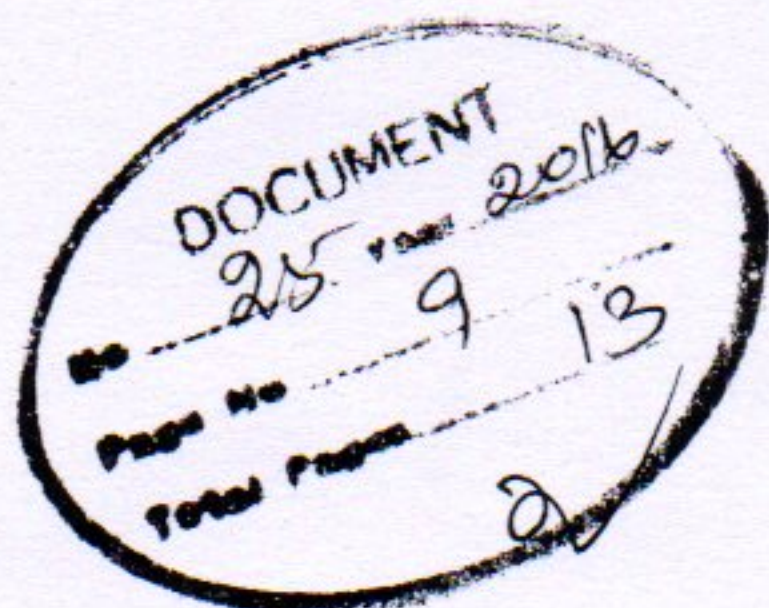




17. APPLICATION OF INCOME AND TRUST FUND: The Trustees shall, after providing for the aforesaid payments and disbursements and after setting apart any sum for sinking Fund, reserves etc apply and utilise the net income or the corpus of the Trust, or the Trust Fund for the fulfillment of all or any of the Public Charitable purpose or objects of running educational institutions referred to in Clause 3 supra by such ways and means as the Trustees may from time to time in their absolute and unfettered discretion determine.
18. TRUSTEES AND THEIR RELATIVES NOT TO BENEFIT: Notwithstanding the power vested with the Trustees under the proceedings clauses, no part of the income of the Trust shall ensure directly or indirectly, and no part of the income or property of the Trust shall be used or applied directly or indirectly, for the benefit of the Trustees or any person who makes a substantial contribution to the Trust or any relative of the Trustees or the person who makes a substantial contribution.
19. NO REMUNERATION TO THE TRUSTEES: The Trustees shall not be entitled to draw any remuneration from the Trust.
20. LIABILITY OF TRUSTEE OR TRUSTEES: In the professed execution of the Trust and powers conferred, no Trustee shall be liable for any loss to the Trust properties arising by reason of improper investment made in good faith or for the negligence or fraud of any agent or employed by him (or by any other Trustee thereof) although the employment of such agent shall not strictly be necessary or expedient or by reason of any mistake or omission made in good faith by the Trustees or by reason of any other matter or things except willful or deliberate fraud on the part of the Trustees, who alone may be subject to be made so liable.
21. INDEMNITY: The Trustees shall be kept fully indemnified and harmless by the Trust against any loss or liability arising against them for anything done by them in good faith pursuant to the power and authority conferred on them by these presents.
22. IRREVOCABILITY: The Trust is Irrevocable.
23. INCOME-TAX MATTERS:
- The activities of the Trust shall be confined to the Territories of India.
  - The Funds of the Trust shall be utilised only towards the objects laid out in the Deed of Trust, and no portion of it shall be distributed in any manner to the Trustees or to persons in Section 13(1)(c) of the Income-tax Act, 1961.




- c. The benefits of the objects of the Trust shall be made available to the general public irrespective of caste, creed, religion or sex.
- d. The Trust shall not carry out any of the objects with the motive of profits of any kind.
- e. Not more than 5% of the income of the Trust/Institution would be applied for any religious purpose or given to religious institutions (any violation found will lead to denial of exemption under sec 80G considering the Trust as Public Religious in nature)
- f. Any amendments, deletions, additions or alterations to the Deed of Trust and/or the codicil to the said deed shall be made only by means of a codicil to the same by the trustees.
- g. Incase of winding up / dissolution, the trust funds would be transferred to institutions having similar objects and enjoying exemptions U/s 11 and 80G of the Income tax Act, 1961.


